This free, two-page application will be used to create a publicly available listing in the Native Farm and Garden Directory, developed and administered by the Office for American Indian, Alaskan Native, and Native Hawaiian Programs (OAIANNHP), Administration for Community Living (ACL), U.S. Department of Health and Human Services (HHS).

The purpose of this program is to develop a searchable list of native farmers and gardeners from federally recognized tribes, who are interested in selling directly to consumers, including Title VI programs that provide meals and supportive services for American Indian, Alaskan Native, and Native Hawaiian elders.

This application must be completed by the farm or garden owner. All sections marked "required" should be filled out to the best of your ability. Please email your completed application to nativefood@acl.hhs.gov in order to be considered for publication. We will email you once your application has been received and processed.
