Project Period: April 1, 2017 – March 31, 2021

Program Report (PPR) Due: June 30, 2021

Financial Report (SF-425) Due: June 30, 2021

Allowable Use of Funds: Part A/B funding for Part A/B services & Part C funding for Part C services

Examples of How Funds Can Be Used: *Part A/B funding:* meals delivered to elders, grocery/ pharmacy / supplies delivery, supplies and equipment for delivering meals, staff to make well-being phone calls. *Part C funding:* respite to family members caring for an elder or elders who are grandparents raising grandchildren or elders who are caring for an adult with a disability. Financial Report (SF-425) Due: Annual report due April 30, 2021. Final report due December 30, 2021.

Allowable Use of Funds: Title VI Part A/B services that are in direct response to COVID-19

Coronavirus Aid, Relief, and Economic Security Act (CARES) Awards

Financial Report (SF-425) Due: Annual report due TBD. Final report due December 30, 2021.

Allowable Use of Funds: Title VI Part A/B services that are in direct response to COVID-19

Financial Report (SF-425) Due: Annually on June 30 (first report due June 30, 2021)

Allowable Use of Funds: Part A/B funding for Part A/B services & Part C funding for Part C services
